Choosing a professional designer for these services allows the family to present other loved ones and guests with a custom keepsake while ensuring that these designs are planned, designed, and executed in a timely manner using quality materials and production equipment. Each page is crafted with keen creative sensitivity and care.

THE DESIGN PROCESS

MAKING A REQUEST

- Contact CMD to request design services. Requests can be made before transition.
- All design requests should be made 72 hours before the confirmed service.
- Information needed to reserve a spot on the Design/Production Schedule:
 - Point of Contact (Name, E-mail and Phone)
 - Name of Deceased
 - Date, Time, Location of Service
- A design request is confirmed when all design materials are received by CMD (i.e., Text, Images, etc.)
- All content should be edited before submission. Extensive edits during the Proofing process can result in additional design charges.
- All text must be submitted in a typewritten format (e.g. Word Document)
- Files not typewritten will incur a \$75 charge.
- All images should be submitted electronically as an attachment or link to an external drive (e.g., Google Drive, Dropbox, etc.)
- Images that do not meet design requirements/standards will not be used.
- Suggested Content
 - Cover Picture
 - Life Summary
 - Order of Service
 - Additional Pictures for Design/Collage
 - Pallbearers and Flower Bearers
 - Acknowledgment
 - Poem, Quotes, Scripture, etc.
 - Note: Submit content that best reflects the character, personality, and style of your loved one.

FORMAT

- The format is based on the family's preference or a content assessment. Common Design Formats: Flat card; Bi-fold; Tri-fold; and Booklet.
- Various sizes are available in each format to ensure the best presentation and use of content.

INVESTMENT

- Investments are calculated by combining Design and Printing costs.
 - Bi-fold (4 pages) \$175.
 - Tri-fold (6 pages) \$200.
 - Book (8 pages) \$350.
- Printing investments are calculated by design format/quantity
 - Single-Sided Card \$1./each
 - Double-Sided Card \$2./each
 - Bi-fold Design \$2./each
 - Tri-fold Design \$2.75/each
 - Book \$4.00+/each
- Invoices for design services should be submitted when services are completed. Please notify CHRISTOPHER MARCS DESIGN if payment needs to be submitted at a later date.

DESIGN TERMS

- All content must be received within 72hours of the confirmed service.
- Rush design requests incur \$75/day charge.
- CMD reserves the right to cancel a job if the materials are not submitted before the requested deadline.

PROOFING and EDITING

- Upon completion of the design, a digital PROOF is submitted to the Point of Contact
- All edits must be documented or submitted as a response to the electronic message containing the digital PROOF.

APPROVAL and SUBMISSION

- The FINAL document is submitted to the Printer upon the Point of Contact's approval and confirmation of number of copies needed.
- Edits can not be made once the file has been approved OR after the deadline.

PRINTING and DELIVERY

- All projects are produced by a professional print service to ensure the highest quality of materials and production.
- The family reserves to the right to commission the design only.
- Designs are printed during business hours Monday-Friday.
- Holiday hours may effect production schedule. Please plan accordingly.
- Rush jobs are subject to incur additional fees.
- Completed projects will be delivered to the supervising Firm (i.e., Funeral Home) or Point of Contact.
- Completed projects will not be delivered to an alternative site or individual without the Point of Contact's permission.
